JOB SUMMARY:

Tacoma Community House is a nationally respected, community-based service center for immigrants, refugees, and members of the South Sound community seeking enrichment and pathways to self-sufficiency. Since 1910, we have helped countless individuals gain the skills they need to transition out of poverty, navigate a new culture, and find personal and professional success.

The Education department offers affordable classes year-round, Monday through Thursday, at various times to accommodate students' schedules. English Language Acquisition (ELA) classes help adults improve their basic English listening, speaking, reading, and writing skills. Our Adult Basic Education (ABE) program helps students to advance their employment standing or to prepare for their high school equivalency tests by improving their skills in reading, writing, and math. Each of our programs offers instruction in computer use to prepare students for the ever increasing technology demands of the 21st century.

Instructors provide in-person classes in the morning and virtual instruction in the afternoon to ELA and ABE students. The Instructor works as part of a team to develop, update, and implement curriculum and is responsible for following program guidelines and record keeping requirements.

Individuals with personal, shared, or lived experience as an immigrant or refugee are strongly encouraged to apply.

PHYSICAL RQUIREMENTS & WORK CONDITIONS

While performing the duties of this job, the employee is *regularly* required to:

- Remain in a stationary position for extended periods of time
- Present and/or instruct in front of up to 50 people in a classroom or virtually
- Operate a computer and other office equipment, such as copy machine or calculator

- Traverse around the building from one room to another
- Access files and/or supplies in cabinets and/or drawers close to the ground
- Communicate with coworkers and with students whose primary language may not be English
- Review electronic and physical data for accuracy

While performing the duties of this job, the employee may *occasionally* be required to:

- Transport up to 20 pounds at a time
- Access files and/or supplies in tall cabinets
- Use metal fasteners in file folders

This position works indoors, in both classroom and office settings, with low levels of noise. There may be opportunities for this position to work remotely on occasion, with supervisor approval and dependent on the needs of the department.

CONTRACT DETAILS

Contract-based staff work according to the terms and requirements specified in a written agreement and are not eligible for fringe benefits, such as health or retirement benefits. They accrue one (1) hour of sick leave for every forty (40) hours worked per Washington State law and are paid an hourly rate on a semi-monthly basis for actual hours worked. The agency pays matching FICA, state industrial insurance, and unemployment taxes on behalf of the staff member.
